HI Nikki,

I just rang EY and they definitely need funding as I suspected so due to the government change to ensure we provide places for 0-4 years old.

74 x 0.1=7.4 7.4x 21,188.00=£156,791.20

It is 1st & Middle school here so this produces the following 74 x 0.23=17.02 pupils for first school 74 x 0.148=10.952 pupils for middle school

The school organisation plan does show that there are plenty of places available in both school types to accommodate this number of children in the coming years. I Have also had confirmation form the Strategic Manager-Head of Education Places, So I would be confident to take off those contributions, as at present we do not have evidence to show there is a need to expand the schools here (until Selwood garden village gets built).

Therefore the total to now ask for is as follows: \pounds 156,791.20 for early years development, that is \pounds 2,118.80 per dwelling so a significant reduction from the ask in 2023.

Dear Katie/Alistair,

Sorry for the delay with my response. I agree that it has been unfortunate that my colleague missed the data back in November 2022. It was human error and a bit of a misunderstanding which can't be helped now. We have always required education contributions in Frome, please see previous response to planning officer on this site. All the sites in Frome have been securing education contributions in S106 due to the pressure which the schools will face when all the planning applications are considered and approved.

At present with approvals for 800+ dwellings and applications for a further 2,300 proposed homes, it is more likely that we will require additional places and/or a new school if the proposed housing developments are all developed.

We currently have a school site reserved in the Town for the development of a new schools (Edmund Park), so the education funding from this development will be pooled with the other collected S106 to ensure that extra capacity will be built in Frome to support the homes approved. There is another school site proposed in the Selwood garden town, which will be to serve some o the children generated from that site, which is also yet to be determined.

74 homes is a significant site, in the letters sent you can see it will generate a significant amount of children. However on this occasion, due to our mistake at pre-app and to reduce the burden on your viability I am able to take off the sum for Early years development as there is a little more capacity at present in the early years settings, and the generation of 7 children may still be able to be accommodated by the time this development is built. In addition I can change the Middle school request to a cost to build

of an extension, which is the most likely project to expand the middle schools which will provide another saving.

Cost oy build an extension in Middle schools is £23,004.00 per pupil, therefore 12 x 23,004.00=276,048

In addition I have not included the 10% uplift on costs which is now required to ensure that schools are able to be built and extended to a net zero standard. If SC are short of funds we will have to borrow to complete the school builds.

I hope that this is an acceptable compromise for you and that you can agree to have these figures drafted in the S106 to ensure that this application is acceptable in planning terms. I look forward to receiving the S106 to help progress this application to approval.
